Committee Mission

The Prosper Valley School Board charges the TPVS Search Committee with the authority to guide the initial phase of the principal search process. This process shall start on February 3, 2017 when the position will be posted and follow the published timeline established by the Superintendent and Board.

The Search Committee shall work with the WCSU Superintendent to complete the search process. The Search Committee shall identify up to three candidates who meet the criteria established by the Search Committee and/or the Board. The Search Committee shall provide input on candidate experience, specific skills, and related background details following completion of the initial process, but shall not rank order the candidate list. The Superintendent and School Board will interview finalist candidates put forward by the Committee. The Superintendent will recommend one finalist candidate to the School Board for employment.

The School Board will establish Screening Committee membership. The Committee shall be co-chaired by two School Board members.

- 3. <u>Principal's Report</u> TPVS will be launching The Prosper Valley Players, a K-6 after-school drama program, led by Katie Jacobsen, beginning March 9th. The Spring Fling Seminars that were a huge success last year will begin again soon. Seminars will include photography, running, VINS, Iron Chef, greenhouse, dance, dog training, cartoon studies, This I Believe podcasts, among others. 3rd through 6th grade teachers have implemented Interim SBACs. TPVS has formed a CAT (Culinary Advisory Team) that will be meeting monthly. The CAT will work together to try to answer the following questions.

How can we support our students' access to locally-sourced ingredients?

How can we work to expand our students' palates and sense of adventurous eating?

How might we make our meal program even better with greater student and adult participation?
